Mr. Vachon moved to enter executive session under 1 VSA 313(a)(1)(B) to discuss labor relations agreements with the Department of Public works AFSCME and ask that the City clerk and City Manager and/or the city attorney join the executive session. Seconded by Mr. Curtis, motion carried.
