A duly warned meeting of the Newport City Council was held on Monday, February 24, 2025, in the Council Room in the Newport City Municipal Building. Present were: Mayor Linda Sullivan, Council President Chris Vachon, Council Members Kevin Charboneau, Rick Ufford-Chase, and Clark Curtis, Police Chief Travis Bingham, Public Works Director Tom Bernier, Fire Chief Kevin Lacoss, Assistant City Clerk/Treasurer Robyn Churchill, members of the Fire Dept, and members of the press and public.

Mayor Sullivan called the meeting to order at 6:00 p.m.

Additions/Deletions to the Agenda

To-Set next meeting: Annual Public Informational Hearing followed by Council Meeting: March 3, 2025 Additions: Payroll Warrant for February 20, 2024, Accounts Payable Warrant for February 21, 2024, and two coin drop requests for American Legion Post 21 Auxiliary on October 4, 2025 and American Legion Post 21 for August 8, 2025.

Council President Chris Vachon presented a plaque to Mayor Sullivan in recognition of her time as Newport's Mayor.

Consent Agenda

Mr. Vachon moved to approve the consent agenda with additions. Seconded by Mr. Ufford-Chase, the motion carried unanimously.

Contract for Services City of Newport and New England Municipal Consultants Ltd-Ratification

Mr. Vachon moved to ratify the Mayor's signature on the contract for services City of Newport and New England Municipal Consultants Ltd. Seconded by Mr. Curtis, the motion carried unanimously.

Grant Agreement Resolution – Single Grantee

Ms. Carter Finegan from NVDA spoke regarding the PM-1 form with updated contact information and the remaining course to settle the grant.

Mr. Vachon moved the Council approve the Grant Agreement Resolution- Single Grantee, Form PM-1. Seconded by Mr. Ufford-Chase, the motion carried unanimously.

Approval of Funding Strategy Developed by NDD with NCIC/NHCLF to help with costs of Contracts Related to the TIF District Application.

Mayor Sullivan spoke regarding progression to date including an approved contract with White & Burke and the MOU with NDD.

Mr. Ufford-Chase moved the City Council approve the funding strategy developed by Newport Downtown Development with NCIC/New Hampshire Community Loan Fund to help with the costs of contracts related to the TIF District Application, which includes authorization for NDD to pursue a \$25,000 proposal to the

NCIC/NHCLF Small Business Professional Assistance Program, 70% of which would be paid by the grant with a 30% match of \$7,500 from the Walmart Funds. Seconded by Mr. Vachon, the motion carried unanimously.

Mr. Ufford-Chase moved the City Council approve the funding strategy developed by Newport Downtown Development with NCIC/NHCLF to help with the costs of contracts related to the TIF District Application, which includes authorization for NDD to pursue a USDA RBDG proposal that Newport Downtown Development will prepare for submission by February 28, 2025 to pay for up to 74% of the remaining costs (estimated at \$200,000 to \$250,000) associated with the TIF application, 26% of which will be a match provided by the Walmart Funds. Seconded by Mr. Vachon, the motion carried unanimously.

Form PVR-4155 Certificate - No Appeal or Suit Pending

In Mr. Cheney's absence, the Mayor advised that this is a form which certifies there are no appeal or suit pending for actions to recover taxes and which will be attached to the final grand list.

Mr. Vachon moved to have the Council sign Form PVR-4155 Certificate - No Appeal or Suit Pending. Seconded by Mr. Curtis, the motion carried unanimously.

Assistant Fire Chief Appointment- Executive Session 1 VSA § 313(a)(1)(F)

Mr. Vachon moved to enter executive session to discuss the appointment of the Assistant Fire Chief and invite the Fire Chief and members of the Fire Department into that executive session. Seconded by Mr. Ufford-Chase, the motion carried unanimously.

No action was taken.

Mr. Vachon moved to appoint Andrew Carbine as Second Assistant Fire Chief, effective immediately. Seconded by Mr. Curtis, the motion was carried unanimously.

Grant Update

No discussion as Mr. Cheney was unavailable.

CSO Loan Signed Document and Supporting Information

Mayor Sullivan made the Council aware that this document goes back to Aldrich & Elliott and keeps getting renewed and that the current renewal was signed off by the Treasurer. Mr. Bernier said the initial one was to do the engineering for the Bluff Road pump station and this addition is to do the engineering so we can utilize the ARPA funds for CSO projects to do the siphon across the river and to line the pipe through Gardner Park soil.

White & Burke Decision Making – Team Leadership Picks/Conflicts of Interest

Mayor Sullivan spoke regarding the upcoming discussions, assignments from the City and through NDD, working with Brian Gray on the TIF, and the need for the established process to continue after the upcoming election.

Mr. Vachon moved that regarding White & Burke decision making, team leadership and picks and who is going to be working within the City, that it is the Mayor and the President of the Council who are the communicators and make those decisions. Seconded by Mr. Curtis, the motion carried unanimously.

Renewal of Casella SWIP Agreement

Mr. Vachon moved to approve the renewal of the Casella SWIP Agreement. Seconded by Mr. Charboneau, the motion carried unanimously.

Broken Meter and Other Meter Issues

Mayor Sullivan noted that currently there are no ramifications for broken meters which are not being allowed to be fixed. Discussion around a formal letter being created and available that identifies the ramifications if there is no response and the meter is not fixed were had.
